Federal Used Car Law. Consumers that purchase used cars enjoy federal law protection. Federal law is applicable to any car dealer or seller who sells more than six used cars a year. Used cars are those that have been driven more than the limited mileage from moving the car from one site to the next, or that is added on during consumer test drives. Wisconsin and Maine are the only states exempt from federal law, because they offer their residents comprehensive used car purchaser protections.
